3. Submit copy of high school/ college transcript which should include class rank and or cumulative GPA as well as your College Board SAT scores. You must have a grade point average of 3.4 or higher.
4. Essay describing how you exemplify the above qualities and why you feel you are a worthy candidate.
5. You must be able to demonstrate leadership and moral qualities that Bruce represented as well as willingness to volunteer time away from academics and athletics.
6. Must show a financial need for the scholarship.
